4. Ensure that matters are uploaded to CaseLines by Friday 16:00, if not yet done, failing which the matter will be at risk of being struck off the roll.
5. Ensure that especially sections 7, 26.7-13 and 30.5-7 of Consolidated Practice Directive 1 of 2024, as appropriate, have been complied with. A failure to do so places a matter at risk of being struck off the roll.
6. **Court starts at 10:00 am, if a party or legal representative is not on the virtual platform by the time the last matter is called, the matter will be struck off for non-appearance.**
7. Ensure that a draft order is uploaded to CaseLines by Friday 16:00.
8. As soon as an order is granted, a draft order in Word reflecting the terms of the order must be emailed to Ms Molusi.
9. Ensure that the draft order includes the following recordal:

11. Generally, the roll will be called by number. Counsel should mention all matters in which they appear at the time that their first matter is heard.
12. Ms Molusi should be informed of removals as soon as possible, and the notice uploaded to CaseLines. No appearance is required for removals reflected on CaseLines by 16:00 on Tuesday.
13. Note that the proceedings are recorded, and that no person may otherwise record the proceedings without prior permission

from the presiding judge.
