2. Introductions by counsel who have not appeared before Hon. Judge R. Strydom (J) will be conducted on the 4<sup>th</sup> floor, in chambers 408 at 09:45am.
3. Parties/Counsel are required to hand in one (1) physical copy of their draft order in court before the hearing commences or as soon as the matter is called to avoid any delays.

4. Parties should ensure that their papers are uploaded accordingly and should refrain from emailing practice notes and draft orders to the Judge's secretary unless directed otherwise.
5. If a matter becomes removed from the roll, the parties are required to immediately inform the Judge's secretary and email him the Notice of Removal.
6. All matters **MUST** be accessible on the CaseLines and the Judge's secretary must be invited to the Caselines file be granted full permissions to the file. This must be done by 12h00 on Wednesday 4 February 2026. If a matter does not have documents or does not appear on Caselines, parties are required to immediately notify the Judge's secretary as soon as the defect is cured.
