**DIRECTIVES**

1. Proceedings will be held in open court in court room GC on the ground floor of the court building.
2. Please note that the hearing on **13 February 2026** will commence at 10h00.  
Introductions may be done promptly from **09h35** at room number 1210 on the 12<sup>th</sup> floor of the Court building.
3. Please take note that legal practitioners must heed the security measures implemented. Accordingly, legal practitioners must assemble at Court GC by no later than **09h35** from where they will be escorted to the senior Judge's chambers.
4. Applicants are further requested to sit together in the seats provided in the **front two or three rows** of the court room.
5. All documents must be accessible on CaseLines failing which matters may be removed or struck from the roll. The 7-step guide for doing so is attached hereto.
6. Matters in which practitioners fail to upload an updated practice note timeously risk being removed or struck from the roll. Practice notes and draft orders sent by email will **not** be accepted. They must be accessible on CaseLines.

7. **TWO (2) hard copies** of the proposed draft order must be available to be handed up to court immediately after an order has been granted.
8. Duplicate electronic court files on Caselines must be archived.
9. Applicants are kindly requested to complete a copy of the prescribed oath/affirmation and bring **one copy** of the oath with them to court on **13<sup>th</sup> February 2026**. The prescribed oath/affirmation will be signed by each applicant in court.
10. Please insert the name of the presiding judges on the order and check that the case number that appears on the order is correct.
11. The signed and stamped orders will be made available on the Court Online system within seven (7) court days from the date of the grant of the order.
12. Kindly note that any person accompanying an applicant is permitted to take photographs/ film video footage in the court room without interrupting court proceedings.
