DIRECTIVES:

1. The trial interlocutory before Acting Judge Khaba will be heard in an open Court, the Court number is to be confirmed.
2. Introductions will be done in Court. Court session will commence at 10:00am, starting with removals and postponements. Counsel will be heard in order of seniority.

3. Appearance will be required in all matters (save for those that have been duly removed by Notice). In the event of any removals or settlement, representatives are to immediately place a note on Caselines and notify the Judge's secretary by email in order to avoid unnecessary reading of matters.
4. Parties must ensure that the files on Caselines comply with paragraphs 7 and 27 of Revised Consolidated Practice Directive 1/2024 and any other paragraphs that may be relevant to that particular matter, by 12h:00pm on 20 February 2026, failing which the matter is not likely to be dealt with.
5. Draft orders must be duly completed and compliant (i.e. must specify the details of instructing Attorney; details of counsel moving the matter; number of the matter on the roll; reflect the date of the hearing; and the Judge's particulars). Draft orders must be uploaded onto CaseLines/CourtOnline. Counsel is requested bring one copy of their Draft Order. The Draft Orders must be signature ready.
6. Practice Notes relevant to this hearing, and properly labelled, are to be uploaded onto Caselines timeously as per the Revised Consolidated Practice Directive 1 of 2024, by no later than 12h00pm on 20 February 2026. Matters which practice notes are not uploaded run the risk of not being heard by the Judge.
7.
