4. The joint practice note in each matter must be uploaded onto Caselines by close of business on **FRIDAY, 27 February 2026**. Counsel are requested to ensure that the joint practice note deals with all aspects identified in paragraph 25.17 of the Judge President's Consolidated Practice Directive 1 of 2024.
5. Authority bundles should be uploaded on the case file on CaseLines by no later than 16:00 on Friday, 27 February 2026.

6. Please note:
  - 6.1. To assist the Judge in the deliberation of the matters on her roll and to prevent matters from being struck, consideration of compliance with the relevant directives pertaining to opposed motions will apply.
  - 6.2. Parties should ensure that proposed draft orders are uploaded in word format onto Caselines at least a day before a particular matter will be heard. Draft orders should indicate the hearing date of the matter, the Judge's name, and the manner in which the matter will be heard. (i.e. open court), and at the end of the draft order the names and details of all counsel/practitioners and their instructing attorneys must be included.
7. Parties must bring ONE hard copy of Draft order sought.
