5. An appearance will be required in all matters (save for those that have been duly removed by Notice).
6. If your matter was properly enrolled but does not appear on this roll, please communicate with the enrolment office.
7. **A Matter will not be heard by Noko J if Practice notes and draft orders are not uploaded**; emailed practice notes and draft orders will not be accepted. They must be accessible on CaseLines and uploaded within the stipulated timeframe, Counsel must also bring a copy to the hearing in court.
8. The orders must be signature-ready, i.e. conclude with “BY THE COURT’, must contain the details of Counsel, reflect the date of the hearing, the correct case number as per the court roll and the Judge’s particulars, remove the word “draft” from the tramlines, delete the “further and/or alternative relief” prayer, etc.
9. If opposed, brief heads must be filed by 09 March 2026 at 12h00 (noon).
10. The court will start with settlements and removals; matters will then be called in terms of seniority.
