All parties should strictly adhere to the provisions of the relevant paragraphs of the **Judge President's latest Practice Directive** and any other subsequent amendments/changes dealing with Urgent Court matters.

**DIRECTIVES FOR THE URGENT COURT FOR 16 TO 20 MARCH 2026 BEFORE HON. JUSTICE NOKO I**

- [1] Please be advised that it is not Protocol to contact a Judge directly, either by email or by phone.
- [2] All matters will be heard in open court (**Court 9B**). Matters enrolled outside normal court hours shall be heard virtually on MS Teams(**parties are directed to have their video background blurred during the proceedings/while addressing the Court**) or in open court, as arranged.
- [3] The court will start at 10h00 on Tuesday, 17 MARCH 2026. Unopposed matters will be heard first.
- [4] Where matters have become settled or will be removed from the roll, this should be communicated to the Judge's Secretary at: [DSereko@judiciary.org.za](mailto:DSereko@judiciary.org.za) as soon as it is confirmed that a matter will not be proceeding.
- [5] Allocation of matters to a specific date does not translate to a matter being sufficiently urgent to be heard on the merits.
- [6] Heads of Argument are to be filed in all opposed matters.
- [7] **Practice Notes and Heads of Argument (where applicable) must be served and filed on Caselines by 17h00 on Friday, 13<sup>th</sup> of March 2026 (to be supplemented if necessary on/before Monday, 16 March 2026 by 10h00am) .** Practice Notes must include details of the legal practitioners, reasons for urgency, a brief overview of the issues, as well as the main issue(s) to be decided, regardless of whether the matter is opposed, and the expected duration of argument.
- [8] Matters for which no Practice Note and no Heads of Argument have been filed in accordance with the Practice Directives will not be entertained.
- [9] Draft orders must be uploaded on Caselines before proceedings begin, and where applicable, immediately after the order is issued.
- [10] The parties' attention is drawn to Chapter 28 of the Practice Directive, which pertains to urgent applications and must be adhered to strictly.
- [11] All new applications must first be registered with the Urgent Court Registrar or the Judge's Secretary, as applicable, who will then bring the matter to the attention of the presiding Judge.

- [12] Applications brought less than 24 hours' notice must comply with *South African Airways SOC v BDFM Publishers (Pty) Ltd and Others* (2015/33205) [2015] ZAGPJHC 293; [2016] 1 All SA 860 (GJ); 2016 (2) SA 561 (GJ) (17 December 2015) at para 26.<sup>1</sup>
- [13] Parties must ensure that matters created on Court online have been populated on Caselines, and where this proves impossible, proceed as stipulated in Chapter 28 of the Practice Directive.
