DIRECTIVES IN RESPECT OF UNOPPOSED DIVORCES BEFORE THE HONOURABLE JUDGE VAN ASWEGEN AJ

1. Parties are required to bring a Draft order clearly indicating the Judge's name.
2. All matters will be heard in an open/physical court.
3. Introductions will be done in court.
4. Parties need not to appear for the purposes of removing a matter, kindly send a notice of removal to Ms M Moropa through her email address and upload same on caselines.

5. Parties are requested to make sure that the copy of the Settlement Agreement on case lines is eligible, if not, an eligible copy should be uploaded before the hearing.
6. Parties are further requested to upload their Practice Notes and the Plaintiff's Founding Affidavit/ Plaintiff's Evidence Affidavit.
7. Litigants with matters with notes that reads **"No Access"** or **"Bundle not Created"** are to ensure that their matters are bundled and migrated to CaseLines by no later than 16h00 on 19 March 2026 and to advise via email once migration has been done.
