DIRECTIVES IN RESPECT OF THE FAMILY COURT BEFORE SMIT AJ

1. The proceedings will be conducted in person at the Gauteng Division, Johannesburg. The court room will be announced on the day roll. If litigants wish to request a virtual hearing, such requests must be directed to Ms M Rammutedi at Mrammutedi@judiciary.org.za .
2. In all applications, parties must ensure that all relevant papers are filed (i.e. notice of set down, practice notes and draft order). No additional papers may be uploaded to Case Lines without prior permission from the Honourable Judge. Requests to upload further papers must be sent to Ms M Rammutedi at Mrammutedi@judiciary.org.za as well as a system wide note on Caselines of such request. If it has not yet been done, a practice note setting out the nature of the case, a summary of the facts and arguments must be filed before 16:00 on **20 March 2026**.
3. The master bundle must be properly indexed and paginated, annexures must be clearly marked and separated. Failure to adhere to this will result in your matter being removed from the roll.
4. The bundles will be frozen by the Judge's Secretary at **16H00** on **20 March 2026**.
5. Please email all draft orders in Word format to Ms M Rammutedi at Mrammutedi@judiciary.org.za by 16:00 on **20 March 2026**. Please also bring two hard copies of all draft orders to court.
6. The draft order to be made an order of court must clearly reflect the Honourable Judge's name (Honourable Acting Justice Smit), number on the roll and date.

UNOPPOSED MATTERS:

7. All unopposed matters (unopposed divorces and rule 43 matters) will be heard on **Tuesday 24 March 2026 @10:00**, subject to the provision as set out below:
 - 7.1. In divorce matters in which there are no minor children, no appearance of the plaintiff will be required, and the matters will be decided on the papers. A legal representative must be present to move the application.
 - 7.2. In such matters the plaintiff must ensure that all the relevant affidavits have been filed and that the draft order and the settlement agreement **are** uploaded timeously on Case Lines.
 - 7.3. The roll will be called by number.

OPPOSED MATTERS AND URGENT APPLICATIONS:

8. The allocation of opposed matters to a date and a time is specified below. Allocation of urgent matters will follow once the roll becomes available.
9. Please note that all matters that do not appear on Case Lines by close of business (16H00) on **20 March 2026** will not be dealt with. If practitioners experience any problems in this regard the Judge's Secretary must be informed by email no later than **16H00** on **20 March 2026**. Practitioners are then to seek assistance from the Court on Line / Caselines helpdesk for rectification and inform the Judge's Secretary once the problem has been resolved.
