(i.e. remove the word “draft” from the tramlines) Orders will be delivered by uploading same onto Caselines for Caselines matters, and on Court-Online for Court Online matters.

5. If counsel is not present and has not been excused when the matter is called, the matter will be moved to the end of the roll and called again. If counsel is not present when the matter is called for a second time, the matter will be removed from the roll.
6. If the matter was not on Caseline, please inform the Secretary uploading the matter on Caselines.
7. It is emphasised that the parties are required to make their documents available on the Caselines system.
