4. **Court will commence at 10:00.**
5. Parties are to notify our office in writing of any removal, postponements or settlements forthwith.
6. An appearance will be required in all matters (save for those that have been duly removed by Notice).
7. The matters will only be heard if:
 - 7.1 Practice notes for the week of 29 June 2026 are filed timeously. Counsel is reminded that a practice note is necessary for each occasion on which an application appears on the roll.
8. Practice notes and draft orders sent by email will not be accepted. They must be accessible on CaseLines and uploaded within the stipulated time frame.
 - 8.1 Draft orders must be uploaded onto CaseLines in PDF and Word format, and Counsel must also bring a copy to the hearing in court.
 - 8.2 The orders must be signature-ready, i.e. conclude with “BY THE COURT”, must contain the details of Counsel, reflect the date of the hearing, the correct case number as per the court roll and the Judge’s particulars, remove the word “draft” from the tramlines, delete the “further and/or alternative relief” prayer, etc.
9. **Failure to comply with any of the above will result in matters being removed or struck off from the roll for non-compliance.**
10. You are advised to regularly check notes on the caselines system in order to address the Judge’s queries.
