3. Unopposed matters will be heard first
4. Matters identified below as having **NO ACCESS/ NO CASELINES BUNDLE/ NO SET DOWN/ / NOT COMPLIANT** must be rectified by no later than **18h00 on Saturday, 4 July 2026**, and an email sent to the registrar of the presiding judge confirming that this has been done.
5. Failure to do this will result in the matter being removed from the roll without allocation.
6. Parties are reminded to ensure that they have complied with the relevant practice directives and rules of this court, and that any deviation therefrom is properly substantiated.
7. Matters which do not comply run the risk of not being dealt with or adverse costs orders being made.
8. Parties' attention is specifically drawn to paragraphs 7 and 28 of Revised Consolidated Practice Directive 1 of 2024.

9. Allocation of matters to a specific date does not translate to a matter being sufficiently urgent to be heard on the merits.
10. Heads of Argument are to be filed in all opposed matters.
11. Applications that are brought on less than 24hrs notice must comply with **South African Airways SOC v BDFM Publishers (Pty) Ltd and Others (2015/33205) [2015] ZAGPJHC 293; [2016] 1 All SA 860 (GJ); 2016 (2) SA 561 (GJ) (17 December 2015) at para 26.**¹
12. All **new applications** must first be enrolled with the Urgent Court Registrar or the Judge's clerk as the case may be, who will thereafter bring the matter to attention of the presiding Judge.
13. Parties are reminded that any insolvency matters are to be dealt with by the insolvency court, and that family matters are to be dealt with by the family court.
