**JUDGES'S DIRECTIVES**

1. All matters will be heard in open court at 10:00.
2. The attention of all parties is specifically drawn to clause 26 of the judge president's practice directive 1 of 2024 dealing with unopposed motions court.

3. Draft orders in the prescribed manner must be uploaded on Caselines. The draft orders must show the particulars of the judge, details of the counsel appearing and the date, including the following disclaimer:

*"This Order is made an Order of Court by the Judge whose name is reflected herein, duly stamped by the Registrar of the Court and is submitted electronically to the Parties/their legal representatives by email. This Order is further uploaded to the electronic file of this matter on Case Lines by the Judge or her Secretary. The date of this Order is deemed to be \_\_\_\_\_"*

4. Senior counsel will be given preference, whereafter matters will be called as they appear on the roll.
5. Where no notice of set down has been given to the defendant at least five days before the hearing date, the matter is to be removed from the roll and timeous notice given.
6. In any matter where the service of summons was affected more than six months before the hearing date, personal service by sheriff of the notice of set down is required unless it can be demonstrated that the defendant is aware that the matter is proceeding on the hearing date.
7. All matters that have not been uploaded to CaseLines by 17:00 on Wednesday, 22 July 2026, will not be heard and will be removed from the roll.
8. Any matter where the required practice notes and affidavits/s in terms of Clause 30 of the Revised Consolidated Practice Directive of 1 of 2024(amended on 12 June 2024) have not been uploaded to Case Lines will be removed from the roll.
9. Should a litigating party wish to remove a matter from the roll, the party is to upload the notice of removal and select the appropriate document type from the document upload selection list. The notice of removal shall be uploaded by 17:00 on 22 July 2026, and the party shall simultaneously notify the secretary of the Judge hearing the matter, per email, of the removal of

the matter. The attention of all parties, in this regard, is specifically drawn to clause 12.20 of the Revised Consolidated Practice Directive of 1 of 2024(amended on 12 June 2024) dealing with notices of withdrawal/removal.
