MODE OF HEARING	PHYSICAL COURT

DIRECTIVES:

1. All **UNOPPOSED** matters will be heard on the **03/AUGUST/2026 IN PHYSICAL COURT STARTING AT 10H00**.
2. Appearance will be required in all matters, save for those that had duly been removed by notice.
3. **ACCESS/ INTERFACE BUNDLE/ PRACTICE NOTE(S)**
 - (a) Parties are to ensure that:
 - (i) all of their matters are accessible on Case Lines by both the presiding Judge and her Registrar, including those that were initiated and interfaced from Court-On Line;
 - (ii) an updated Practice Note (of a joint nature, where applicable) is timeously uploaded; and,
 - (iii) a complete set of papers has been uploaded.
 - (b) In the case of inaccessibility, the matter will be deemed as unripe for hearing and, thus, up for removal until and/or unless the applicant moves, as swiftly as possible, to cure the defect thereof, as well as justifying why the matter concerned should not be removed.
4. **COMMUNICATION VIA WIDELY SHARED NOTES ON CASELINES**
 - (a) The Judge may post queries via widely shared notes posted on the electronic file.
 - (b) Legal representatives are to look out for these communications and are requested to respond to such communications.
5. **DRAFT ORDER(S) AND HEADS OF ARGUMENT**
 - (a) A Draft Order, indicating the date and particulars of the Judge must be filed on Court-On-Line/ CaseLines for the Court to consider.
 - (b) Heads of Argument, where and if applicable or necessary, must be filed.
