NOTICE REGARDING IMPLEMENTATION OF THE JUDGE PRESIDENT'S DIRECTIVES FOR THE COURT

1. HEARING DATE: TIME; AND, MODE

- 1.1 All matters are to respectively proceed on the day of the hearing indicated on the roll at 10h00 AM.

- 1.2 Proceedings will take place in an OPEN courtroom to duly be announced.
- 1.3 Only in exceptional justice-oriented circumstances deemed by the Presiding Judge to aid in getting the matter expeditiously disposed of, and by prior arrangement with the Judge's Registrar, a virtual hearing mode, alternatively proposed (and agreed-upon by both parties) may be resorted (in)to.

2. INTRODUCTION & APPEARANCE

- 2.1 Introduction will be done in Court, upon the matter being called on record.
- 2.2 Appearance will be required in all matters, save for those that have duly been removed by notice.
- 2.3 Thus, Removal Notice(s) must be uploaded as reasonably early as possible to avoid the need for physical appearance or, at the very least, a rational expectation of it by the Court.

3 ACCESS/ INTERFACE BUNDLE/ PRACTICE NOTE

- 3.1 Legal representatives are to ensure that:
 - 3.1.1 all of their matters are accessible;
 - 3.1.2 the interface bundle is created for all Court-On-Line matters, if any at all, to be accessible on CaseLines by both the presiding Judge and his/her Registrar in the main;
 - 3.1.3 updated Practice Note (of a joint nature, where applicable) is timeously uploaded
 - 3.1.4a complete set of necessary papers has accordingly been uploaded.

4 DRAFT ORDERS

- 4.1 Draft Orders must be duly completed and compliant (i.e. they must contain the details of counsel; reflect the date of the hearing; and, reflect the Judge's particulars).

- 4.2 In line with para (a)(i)(ii) and (ii) above, Draft Orders must be uploaded onto Court-On-Line/ CaseLines, of which Counsel must, in addition thereto, physically bring one hardcopy to the hearing in Court.
- 4.3 These orders must be signature-ready (i.e. please remove the word "DRAFT" from the tramlines in order to reflect "COURT ORDER", and delete the "further and/or alternative relief" prayer etc.).

5 COMMUNICATION VIA WIDELY SHARED NOTES ON CASELINES

- 5.1 The Judge may communicate with the parties' legal representatives via widely shared notes posted on the electronic file.
- 5.2 Legal Representatives are to look out for these communications and are requested to respond to such communications.
