This order must be signature ready (i.e. remove the word "draft" from the tramlines, delete the "further and/or alternative relief" prayer etc.) Orders will be delivered by uploading same onto Caselines/Court Online. Parties with Court Online matters must follow the "7-Steps" to ensure that their Court Online matters bundle onto CaseLines.
4.
