UNOPPOSED DIVORCE COURT ROLL FOR 28 AUGUST 2026

Directives:

1. The Hon. Judge Wanless will hear the matters hereunder in open court on **Friday, 28 August 2026 at 10h00** (The relevant court number will be disclosed in due course – please see JSA website for daily court allocations).
2. An appearance will be required in all matters (save for those that have been duly removed by Notice).
3. The attention of all parties is specifically drawn to the provisions of the relevant paragraphs of the Judge President's latest Practice Directive dealing with Practice Notes for Unopposed Motions. These are to be uploaded by no later than **noon on Wednesday, 26 August 2026**, failing which the matter will be removed from the roll. The purpose of the Practice Note is to assist the Court in the

efficient disposal of the matter. In the premises, a Practice Note which merely describes what type of matter the Court is dealing with and/or does not refer the Court to the relevant documents and where these are to be found on Caselines, is of no assistance at all. The Practice Note should set out **all** the pertinent issues of the matter and precisely where the relevant documents in respect thereof may be found on CaseLines. In this way, the Court will be able to ascertain whether the Plaintiff is entitled to the relief sought or not. **If a Practice Note does not comply with the foregoing the matter will be removed from the roll with an appropriate order as to costs.**

4. All material documents are to be placed before the court, including certified copies of any **settlement agreement and the marriage certificate**, which must be uploaded to Court Online and then made available on Caselines by no later than **noon on Wednesday, 26 August 2026**, failing which the matter will be removed from the roll.
5. Draft orders must be duly completed and compliant (i.e. must contain the number on the roll, the correct case number, the details of counsel, reflect the date of the hearing, and the Judge's particulars). Draft orders must be uploaded onto CaseLines, and Counsel must bring a copy to the hearing in court. This order must be signature ready (i.e. remove the word "draft" from the tramlines).
6. When moving their matters, Counsel will be expected to hand up the order in hard copy.
7. Counsel are excused from introducing themselves in chambers.
8. If any parties are experiencing any difficulties with court online, they are to seek assistance timeously from the court online helpdesk staff at office 008.
