As per the Judge President's Consolidated Practice Directive of 18 September 2020, the Honourable Judge Siwendu has issued the following instructions for unopposed applications on the roll for **Monday, 19 April 2021**:

1. Parties are required to fully upload their matters to CaseLines by **Thursday, 14h00, 15 April 2021**.
2. This includes practice notes and draft orders. Parties will need to obtain the leave of the Court to file documents thereafter.
3. A Microsoft Word version of the draft order must be emailed to the Judge's Secretary by **Thursday, 14h00, 15 April 2021**.
4. The hearings will proceed via video conference on MS Teams. The link for the hearing is provided on the roll. Legal practitioners are expected to familiarise themselves with the video conference etiquette guidelines set out in the Consolidated Practice Directive.
5. Self-represented litigants will be accommodated in Courts 9E or 9F on the 9th floor at the Johannesburg High Court; attorneys are required to advise unrepresented litigants of same, where possible.
6. Stamped and signed copies of draft orders will be uploaded to CaseLines within 7 days of the hearing.
