It is not permitted to record or take photographs of the proceedings without the leave of the Court.*
- 3. Self-represented litigants will be accommodated in Courts 9E or 9F on the 9th floor at the Johannesburg High Court in circumstances where they do not have access to their own facilities to join the videoconference via MS Teams; attorneys are required to advise unrepresented litigants of same, where possible.*
