*As per the Judge President's Consolidated Practice Directive of 11 June 2021, the Honourable Acting Judge Dosio has issued the following instructions for urgent applications on the roll for the week of **15 November 2021**:*

- 1. Please note that the CaseLines bundle has been frozen in each matter. Parties will need to alert the Judge's Secretary via email of any further documents which need to be filed in the matter.*
- 2. The hearings will proceed via video conference on MS Teams. The link is provided below. Legal practitioners are expected to familiarise themselves with the video conference etiquette guidelines set out in the Consolidated Practice Directive. It is not permitted to record or take photographs of the proceedings without the leave of the Court.*
- 3. Self-represented litigants will be accommodated in Courts 9E or 9F on the 9th floor at the Johannesburg High Court in circumstances where they do not have access to their own facilities to join the videoconference via MS Teams; attorneys are required to advise unrepresented litigants of same, where possible.*
- 4. Should an order be granted, a Microsoft Word version of the draft order must be emailed to the Judge's Secretary as soon as possible after the matter has been heard.*
