It is not permitted to record or take photographs of the proceedings without the leave of the Court.*
- 3. Should an order be granted, a Microsoft Word version of the draft order must be emailed to the Judge's Secretary as soon as possible after the matter has been heard, together with the settlement agreement, if applicable.*
