8. The draft order which is uploaded must clearly reflect the surname of the Judge, date being 12 January 2022, the name of the counsel, the attorney and their respective e-mail addresses. If the phrase "Further or/and alternative relief"

appears in your draft order it must be deleted.

9. Counsel and attorneys are directed to check CaseLines. Where possible the Judge has left a note to indicate problems in the matter. Counsel and attorneys

are directed to not reply to the note on CaseLines.

10. All documents should be uploaded by <u>12:00 on Tuesday 11 January 2022</u>. If the documents are not in order, the matter will be removed from the roll. No late

documents may be uploaded. If for some reason you are unable to upload the

draft order, you may e-mail it to JHefer@judiciary.org.za.
