- Legal Practitioners /Litigants are to take note of the allocated time for the hearing of their matters.
- Non-appearances at the allocated time will result in matters been struck off the Roll, Matters will have to be set down again in the usual manner.
- Stood down matters will be allocated a time slot after 12h00 by the Judge hearing the matter. Legal Practitioners must leave the court ‘precinct’ and return at allocated times after 12h00.
- Observing of social distancing: It is recommended that Legal Practitioners /Litigants arrive and be in attendance in the designated area outside the court building not later than 15 minutes before the allocated time on the roll. Legal Practitioners /Litigants will be allowed into the court building 5 matters at a time.
- When Legal Practitioners /Litigants in a matter are finished, he/she will exit the courtroom and immediately exit the building.
- Urgent matters will be dealt with after the roll or by another Court.
