CHAMBER COURT

Chamber Court (Motion Court) operation procedure (Covid 19)

1. Only 3 (three) matters will be dealt with at a time.
2. For each matter only counsel and one attorney or accompanying person will be allowed into court.
3. Ideally, there ought to be a maximum of 9 persons in the well of the court at any one time.
4. The front row of counsel stations is to be left unoccupied. Counsel may occupy the 2nd and 3rd rows and attorneys and others occupying spaces in the public area at the rear of the court.
5. Everyone in court **MUST** wear a mask at all times and must ensure that appropriate social distancing is observed.
6. Only when all the matters in any particular batch have been disposed of will everyone in that batch be allowed to leave the courtroom.
7. In order to facilitate the smooth influx and egress, counsel and others must leave via the far rear door so as to permit the smooth entrance of the next batch of matters via the normal entrance at the far right side of the court.
8. While waiting their turn outside court counsel (and others) are reminded to observe proper social distancing and are requested to remain in reasonable "earshot" to avoid delays.
