- Legal Practitioners /Litigants are to take note of the allocated time for the hearing of their matters.
- Non-appearances at the allocated time will result in matters been struck off the Roll, Matters will have to be set down again in the usual manner.
- Stood down matters will be allocated a time slot after 12h00 by the Judge hearing the matter. Legal Practitioners must leave the court ‘precint’ and return at allocated times after 12h00.
