We have noted with great concern that Practitioners rush to enroll their matters but do not file on time resulting in many cancellations of matters on the roll and by doing so defeating the whole purpose of the Special roll. As such a decision was taken that moving forward every Practitioner must file court bundles at the same time of enrolling a matter with Roll Planners.
