#### **RESERVED JUDGMENTS REPORT**

#### 1. Introduction

The Judicial norms and standards for the performance on judicial functions provide, in terms of paragraph 5.2.6, that judgments in both civil and criminal matters, should generally not be reserved without a fixed date for handing down. Judicial Officers have a choice to reserve judgments *sine die* where circumstances are such that the delivery of a judgment on a fixed date is not possible. The norms and standards further determine that save in exceptional cases where it is not possible to do so, every effort shall be made to hand down judgments no later than three (3) months after the last hearing.

At the meeting held on 28 September 2018, the Heads of Court resolved that a reserved judgments report containing a list of judgments outstanding for more than 6 months, will be published on the Judiciary's website.

#### 2. Reserved Judgments overview during the reporting period

As at the beginning of term 1 of 2023, a total of **904** judgments were indicated as reserved. A total of **184** of these judgments, representing an overall 20% of the reserved matters, had been reserved and were outstanding for a period exceeding 6 months. The remaining 720 of these judgments, representing an overall 80%, had been reserved for a period of less than 6 months.

From the table below, it can be seen that the Labour Court, Johannesburg, with a total of 116 reserved matters, had the highest number of reserved judgments, followed by the North West Division of the High Court, Mahikeng, with 112 reserved matters.

The Gauteng Local Division, Johannesburg, had the highest proportion of reserved judgments older than 6 months, representing 93% of all matters, followed by the Northern Cape Division of the High Court, Kimberley, with 52%.

The highest number of reserved judgments, outstanding for a period exceeding 6 months, were in the Labour Court, Johannesburg, with a total of 24 matters, followed by the Northern Cape Division of the High Court, Kimberley, with 23 matters. The Labour Court, Cape Town, and the KwaZulu-Natal Division of the High Court, Pietermaritzburg, had 19 and 18 matters outstanding for a period exceeding 6 months, respectively. A noteworthy observation from the table below is that there were no reserved judgments, longer than 6 months, in the following Divisions of the High Court: Free State Division of the High Court, Bloemfontein, Limpopo Division of the High Court, Polokwane, as well as the Mpumalanga Local Division, Middelburg.
