

# RESERVED JUDGMENT REPORT FOR THE CHIEF JUSTICE

TERM 1, 2020 RELEASE

**MARCH 2020** 



## **Reserved Judgments**

### 1. Introduction

The judicial **norms and standards**, in paragraph 5.2.6 provides that judgments in constitutional, criminal and civil matters should generally not be reserved without a fixed date for handing down. Judicial Officers have a choice to reserve judgments *sine die* where circumstances are such that the delivery of a judgment on a fixed date is not possible. The norms and standards state that the Judicial Officers should make every effort to hand down reserved judgments no later than three (3) months after the date of the last hearing.

At the meeting held on 28 September 2018, the Heads of Court resolved that the reserved judgments report containing a list of judgments outstanding for 6 months or longer will be published on the OCJ website.

### 2. Statistics Overview

During the beginning of term 1 of 2020 there were a total of **62** judgments reserved for longer than six months since the date of last hearing. These 62 reserved judgments are accounted as follows: Constitutional Court (4); Labour Court Durban (1), Labour Court Johannesburg (6), Eastern Cape Division, Grahamstown (1), Eastern Cape Local Division, Port Elizabeth (2), Gauteng Division, Pretoria (15), Gauteng Local Division, Johannesburg (6), KwaZulu-Natal Division, Pietermaritzburg (8), KwaZulu-Natal Local Division, Durban (9), Limpopo Local Division, Thohoyandou (4), Mpumalanga Division, Mbombela (1), Northern Cape Division, Kimberley (1) and Western Cape Division, Cape Town (4).
