REFLECTIONS OF THE CHIEF EXECUTIVE OFFICE

This report provides progress on the implementation of 2018/19 Annual training schedules for Judges and Magistrates, 2018/19 Research Agenda as well as an update on support to foreign Judicial Training Institutions. It also provides an update on the training of Traditional leaders and induction of new Council members.

For the current financial year, 144 workshops were conducted attended by Judges, Regional and District Magistrates as well as Aspiring Judicial officers. SAJEI received additional requests from the leadership of the Judiciary for workshops informed by operational needs.

Two seminars were planned for Judges and five were conducted. Additional seminars were on Diversity and Inclusion, Promotion of Equality and Prevention of Unfair Discrimination (PEPUDA) as well as Court Annexed Mediation conducted by Judge Ben Hadfield and Judge Clifford Wallace from United States of America (USA). A total of 20 workshops for Regional Magistrates were submitted in 2018/19,

about nine were cancelled. The District Magistracy submitted 122 workshops of which 117 took place, other workshops were either postponed or cancelled. Training for aspiring Judicial officers was conducted for all three levels of the Judiciary.

A total of 20 Ad-hoc workshops were conducted. The ad-hoc workshops are triggered by additional needs identified by leaders of the Judiciary. During this financial year, SAJEI launched a new four-day program named "Human Rights week" for the Magistrates. The purpose of the program was to discuss human rights related topics in order to enhance the skills of Judicial Officers. Topics that were covered focused on undocumented children, statelessness, dealing with foreigners during

first appearance, HIV/TB and Human Rights, Housing Rights, media presence during court proceedings and LGBTIQ+.

SAJEI has produced three Newsletters for the lower court Judiciary and one Journal during this financial year. Also, SAJEI has conducted two regional initiatives on Environmental law and Trafficking in Persons, respectively. A team of experienced Magistrates have developed a manual on Environmental law. They are currently updating it to include Wildlife Trafficking. A Colloquium on Trafficking in Persons was attended by Judicial Officers from Botswana, Lesotho, Zimbabwe, Eswatini, Namibia, Tanzania and Uganda. The outcome of the Colloquium was an action plan which has not been implemented due to budgetary constraints.


In December 2018, SAJEI launched and piloted a training programme on HIV/TB and Human Rights. The program will be rolled out to three provinces in 2019/20 financial year.

SAJEI is rendering local support to the International Organization for Judicial Training (IOJT) conference which is scheduled to take place in Cape Town from 23rd to 26th September 2019. The theme of the conference is "Judicial Training: A Key to the Successful Transformation of the Judiciary". The Local Organising Committee is chaired by the Deputy Chief Justice. LEGISLATIVE AND OTHER MANDATES

In discharging its mandate, SAJEI is guided by the Constitution, South African Judicial Education Institute Act 14 of 2008 as amended by Judicial Matters Amendment Act 24 of 2015, other relevant legislation and policies.



The Constitutional mandate of SAJEI emanates from section 180 (a) of the Constitution which makes provision for National legislation to be promulgated dealing with the training of Judicial officers



SOUTH AFRICAN JUDICIAL EDUCATION INSTITUTE ACT 14 OF 2008

The SAJEI Act is the basis for the legislative mandate of the Institute. The Act establishes the Institute and provides for its mandate.

MAGISTRATES COURT ACT 99 OF 1993

The compulsory training of newly appointed Magistrates is provided for in section 3(1)(f)(i) of the Magistrates Act 99 of 1993. The section provides that: "No person shall be appointed as Magistrates unless he has successfully completed an applicable course".



The conference provides an opportunity for training, networking and exchange of best practices in Judicial training. The Judge President of Gauteng division requested a diversity seminar. It was attended by Judges from Johannesburg and Pretoria.



REGIONAL MAGISTRATES

The 2019/20 Training schedule consisting of 21 Judicial education courses was received and tabled at the Curriculum Planning and Development Committee on 25th January 2019. The program was recommended to SAJEI Executive Committee. Subsequently, SAJEI received a revised schedule which has been referred to the Curriculum Committee for review. The Curriculum Committee will consider the revised schedule on the 5th April 2019.

DISTRICT MAGISTRATES

The 2019/20 Training schedule consisting of 121 Judicial education courses was tabled at the Curriculum Planning and Development Committee on the 25th January 2019. The schedule was supported and referred to Exco for recommendation to Council. Exco has considered the training schedule and resolved to recommend to Council for approval

Due to the limited number of Judicial Educators, SAJEI has requested the Magistrates Commission to consider additional posts of Judicial Educators. On the 22nd February 2019, the Commission resolved that SAJEI should apply for the appointment of acting Magistrates in order to facilitate the seamless implementation of the schedule.

One of the Judicial Educators, Mr Mashau Ramalebana has been appointed as a Regional Magistrate effective 1st March 2019. The Magistrates Commission has resolved that an acting Magistrate be appointed in George so that Mr Ramalebana can continue to render duties at SAJEI for a period of six months effective 1st April 2019 whilst recruitment is underway.

SAJEI organized the first Human Rights week from the 2nd to 5th October 2018 in partnership with United Nations High Commissioner for Refugees (UNHCR) (Refugee rights), International Commission of Jurists (Housing Rights) and the Williams Institute (LGBTIQ+ Rights). The program also included gender and HIV as well as testimonies by vulnerable groups. Mr Leigh, an HIV and Gender activist delivered a testimony on challenges experienced by transgender and HIV positive people in court. It is with sadness that Mr Leigh passed on in January 2019 due to TB related complications. There were dedicated themes for each day. This workshop was well received by Magistrates in attendance and partners.

HIV/TB, GENDER & HUMAN RIGHTS PROGRAM

SAJEI has launched a program on HIV/TB, Gender and Human Rights in October 2018. The program was developed with the leadership of the District Magistracy and experienced Magistrates. The program will be rolled out to provinces in the new financial year.

COURT ANNEXED MEDIATION AND CASE MANAGEMENT

Chief Judge Clifford Wallace and Judge Ben Hadfield from the USA have conducted several workshops on Court Annexed Mediation and Case Management attended by Judges, Magistrates and members of the legal profession. A total of 82 members of the Legal profession attended a one-day seminar. From the evaluation feedback, participants indicated that the training should be mandatory for all members of the legal profession and it should be conducted over a period of 5 days.

INTERNATIONAL ORGANIZATION ON JUDICIAL TRAINING (IOJT) CONFERENCE

The IOJT in partnership with the National Centre for State Courts (NCSC) will be hosting a conference from 23rd to 26th September 2019. The venue for the conference is ICC Cape Town. The Office of the Chief Justice (SAJEI) will be providing local support.

The International Organization for Judicial Training (IOJT), is an international organization whose mission is:

- a. To promote the rule of law;
- b. To consider common issues for the training and education of Judges;
- c. To promote and advance cooperation among its members; and
- d. To facilitate the international exchange of information.

The conference is held biennially and the previous one was in the Philippines. The information on the conference is on IOJT website.

In 2016, the SAJEI Council sent a delegation to the IOJT conference in Brazil. Thereafter the National Centre for State Courts has provided support to SAJEI on Facilitation skills. Mr. John Meeks of NCSC, an experienced Judicial Educator conducted training for about 60 Judicial Officers on facilitation skills in 2016 and 2018. NCSC has hosted a delegation led by the former Deputy Chief Justice Dikgang Moseneke.



The theme of the conference is "Judicial Training: A Key to Successful Transformation of the Judiciary."

TRAINING OF TRADITIONAL LEADERS

SAJEI addressed the National House of Traditional Leaders in March 2018 on Judicial Skills training. Thereafter, SAJEI was invited to Provincial House of Traditional Leaders in Limpopo, KwaZulu Natal and North West. The training needs have not been received from these three Houses.

In February 2019, SAJEI received a request for training on Judicial skills from the Eastern Cape. The workshop is tentatively scheduled for May 2019. SAJEI is awaiting further communication from Traditional Leadership and CoGTA in the Eastern Cape.
